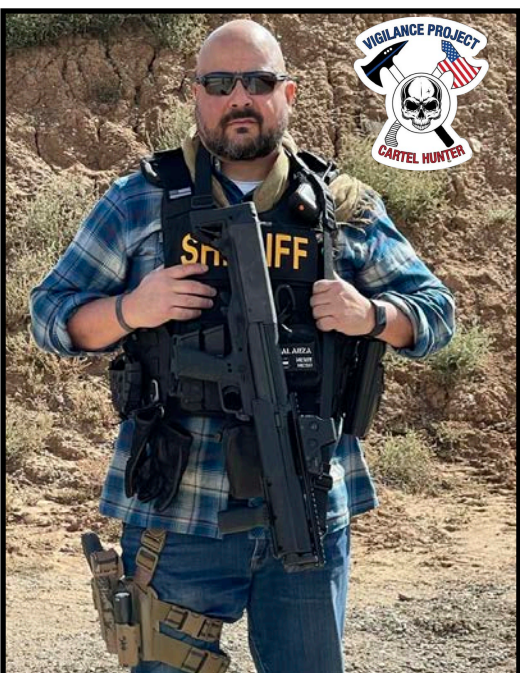

He has been recognized as lead Detective in the 3 largest narcotics investigations in his AOR, which targeted a CPOT and RPOT “plaza bosses”, recognized as conducting the largest UC buy in SW Colorado worth \$1.1 million, and credited with seizing 13 million dollars worth of narcotics in 2025 alone. He possesses an extensive history; being a Mexican diplomat in the U.S., bearing an A-1, and later G-1 diplomatic status; first-hand and personal accounts regarding these groups dating back to the Guadalajara Cartel; and has investigated members of Los Zetas, Sinaloa, Golfo, La Familia Michoacana, H3 and other MTCOs/MFTOs. His experience as a diplomat allowed him to train with the Mexican Navy, Mexican Army, Mexican Estado Major Presidencial (Mexican Presidential Security Service), as well as other agencies.

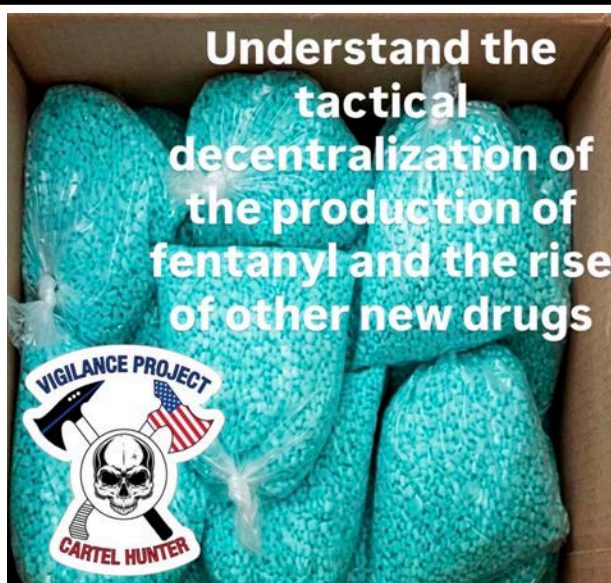
